Why leave a legacy?

Leaving a gift in your will to the Catholic Children's Society (Plymouth) is an inspiring way to show you care by providing support and security to children and families when they need it most.

A legacy does not need to be a large sum of money. A gift in a Will however large or small plays an important part in continuing the work of the Society as we rely entirely on donations from generous supporters.

£50 could provide a much needed school uniform for a child whose parents are finding it hard to make ends meet



£100 could buy essential baby equipment for a family with little money to spare

£500 could help a number of families receive support through our parenting programme, allowing them to become better parents and enjoy family life

£1000 could provide a child leaving care, with the basic items required to set up home on their own for the first time or pay a deposit and first months rent on their accommodation

What to do next

It is recommended to seek legal advice when making a Will. A solicitor will ensure that your wishes will be carried out correctly. They will advise you about the value of your estate and what will happen to it after your death. They can also discuss with you **Inheritance Tax** and how to allow your executors to manage your estate tax- effectively.

There are a number of ways to include the Society in your Will: residuary, pecuniary and specific.

Residuary: by leaving a percentage (or the whole) of the residue of your estate after all dependents, other gifts and costs have been provided for

Pecuniary: by leaving a specific sum of money which can be index-linked to preserve its value

Specific: by leaving a particular asset to the charity

A solicitor will advise on the specific wording you need to use for different types of gifts.

Already made a Will?

Minor changes can be made to incorporate the Society in an existing Will by way of a codicil.

Please remember that a Will remains valid unless you marry, remarry or you make a new one.

To continue our vital work we need to know that we can rely on legacies for future income.
