TERMS AND CONDITIONS

Commitment of the Catholic Children's Society (Plymouth)

The **Catholic Children's Society (Plymouth)** agrees to arrange and confirm registration of the athlete to the Rome Marathon as part of a team registered under the name of Catholic Children's Society (Plymouth). Accommodation will be provided for two nights at a convent in Rome. The Society will also provide each runner with a running vest and sponsorship pack. *Each participant will be responsible for making their own travel arrangements to and from Rome*

Minimum fundraising commitment on behalf of the runner

To secure a place, runners must pledge to run the Rome Marathon for the Catholic Children's Society (Plymouth) and to raise in sponsorship a minimum of £600 which must be paid to the Catholic Children's Society (Plymouth) no later than 3 months after the date of the marathon.

Deposit

We ask that you pay a deposit to the Catholic Children's Society (Plymouth) of £120 as a guarantee that you will raise, or exceed, the amount pledged on your application form. The Society will refund the deposit to you no later than 28 days after you have paid in full your minimum sponsorship. The Society reserves the right to retain all (or part) of your deposit if you pay less than the minimum sponsorship amount.

Paying your sponsorship funds

The Catholic Children's Society (Plymouth) will advise you on the recommended methods of paying in your sponsorship. This is to ensure that the Society can easily trace funds that you pay in. The amount which the Society deems to have been raised by you will be the amount that the Society has recognised as having been paid in to its bank account by you.

Payment deadline for sponsorship is 3 month after the date of your run. If you need more time to collect sponsorship, please let the Society know in writing in advance of this date. The Society will refund your £120 deposit within 28 days of receiving sponsorship payments which equal or exceed the amount that you pledged.

Monies reclaimed by the Catholic Children's Society (Plymouth) from the Inland Revenue for Gift Aid (or any other charity tax scheme) **do not** count towards the total value of the sponsorship you raise. This is due to the delay in receiving the Gift Aid and the fact that this is not guaranteed to us.

Cancelling your place

If you decide not to run for the Catholic Children's Society (Plymouth), or choose to run for another charity, you must inform the Society as soon as possible in order that your place can be re-allocated & accommodation cancelled. The Society will refund your deposit minus any costs incurred.

Conditions of race organisers

Athletes must be 20 or older on the race day. In order to register for the race, these athletes must provide **one** of the following documents:

- Members of foreign Athletic Associations affiliated with either IAAF or IPC must send a copy of their membership card (valid at least until the race day complying with rules and regulations on road running enforced in the athlete's country of residence) upon registration or
- In compliance with the Italian law for safety in sports, athletes who are not members of any of the above mentioned associations must produce **a medical certificate** for competitive athletics. It must be valid on the date of the event and issued by the athlete's general practitioner in the athlete's country of residence. The certificate must contain evidence of the following medical examinations and tests: medical examination – complete urine test – ECG at rest and post exercise - spirometry.

The certificate can be issued on the letterhead of your GP (complete with the physician's signature) or by completing the enclosed medical form.
